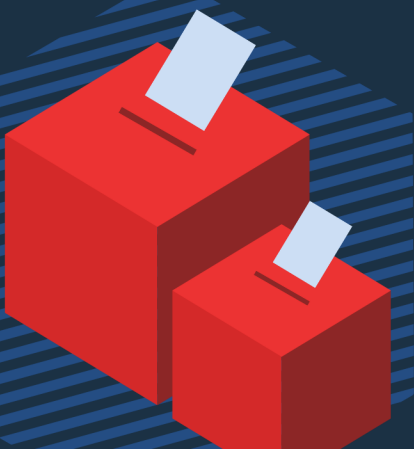

FRESNO COUNTY - MEASURE A

Yes

Measure A would reverse a Sacramento mandate requiring Fresno County's District Attorney and Sheriff run in presidential election cycles and restore them to running in midterm election cycles.

FRESNO COUNTY - MEASURE B

Yes

Measure B would restore local control of determining the place-name for municipalities and geographical markers from Sacramento and Washington bureaucrats.

FRESNO COUNTY - MEASURE E

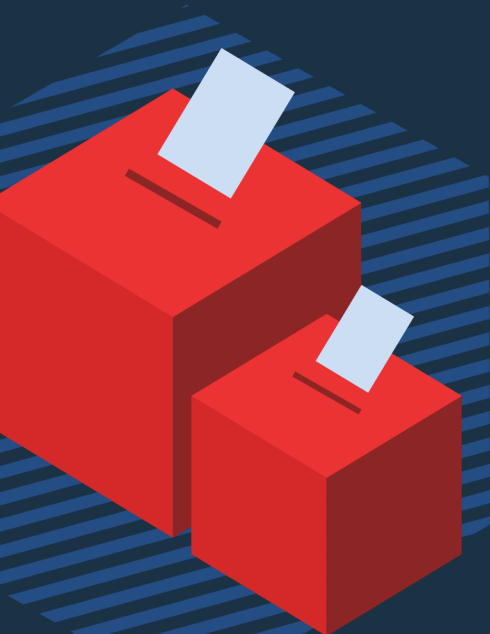

Measure E would enact a first-of-its-kind countywide, 0.25% sales tax for 25 years to finance programs and facilities at Fresno State in addition to tax dollars appropriated by the state and CSU system budgets.

PROPOSITION 1

No

Prop. 1 authorizes \$6.38 billion in general obligation bonds for mental health facilities and homeless response programs. Since 2019, California has spent nearly double on homelessness response between general fund dollars and COVID relief, to negligible results.
